


HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 361
NOTICE OF MEETING

Notice is hereby given to all interested members of the public that the Board of Directors ("Board") of the above captioned District will hold a regular meeting on **Friday, January 9, 2026, at 12:00 p.m.,** at **480 Wildwood Forest Drive, The Woodlands, Texas, 77380** (** *please see below for remote meeting option) to consider and authorize any action in connection with the following:

1. Public comments (*note public comment policy in effect*);
2. Minutes of prior Board meeting(s) (*December 12, 2025*);
3. Bookkeeper's Report, including payment of bills, review of investments, and related matters;
4. Tax Assessor's Report, including collection/uncollectible accounts, delinquent collections, installment agreements, bank agreements, and payment of tax bills;
5. Resolution authorizing additional penalty on delinquent personal property taxes;
6. Resolution granting exemptions from taxation for 2026;
7. Engineer's Report, including WWTP, Water Plant, and other engineering matters;
8. Operator's Report, including Badger Meter Beacon Master Agreement;

10. Security matters, including contract renewal/update options;

Persons with disabilities who require auxiliary aids or services at the meeting are asked to contact the District's attorney at 832-789-1899 at least three (3) business days prior to the meetings so that appropriate arrangements can be made. Residents of the District have the right to request the designation of a meeting location within the District under Water Code Section 49.062(g). *The District reserves the right to adjourn into executive session at any time during the course of this meeting to discuss any of the matters listed above or otherwise, as authorized by Texas Government Code Ch. 551.

As required by Texas Water Code §49.062-.063, the District hereby outlines the following petition process regarding its meeting location: After at least fifty (50) qualified electors are residing in a district, on written request of at least five (5) of those electors, the Board shall designate a meeting place and hold meetings within the district, or if no suitable place exists than not further than 10 miles from the boundary of the district. On the failure to designate the location of the meeting place within the district or within 10 miles from the district, five (5) electors may petition the Texas Commission on Environmental Quality ("TCEQ") to designate a location. If the TCEQ determines that the meeting place used by the district deprives the residents of a reasonable opportunity to attend district meetings, the TCEQ shall designate a meeting place inside or outside the District which is reasonably available to the public and require that the meetings be held at such place.
